### 1. Call to Order

Chairman Brown called the meeting to order at 9:05 AM.

### 2. Public To Be Heard

#### 3. Approval of Minutes

It was moved by Hunter, seconded by Frank, to approve the 2-05-04 CCAC Minutes as submitted. Motion carried unanimously.

It was moved by Hunter, seconded by Silver-Ragheb, to approve the 1-29-04 CCAC Minutes as submitted. Motion carried unanimously.

It was moved by Hunter, seconded by Frank, to approve the 1-22-04 CCAC Minutes as submitted. Motion carried unanimously.

Committee Member Frank discussed the advertising schedule; five one-quarter page advertisements would be published due to publishing one week earlier than scheduled; asked if the Committee wanted to omit advertising on February 18, 2004 (to comply with the original four (4) one-quarter page advertisements).

There was consensus to cancel the advertisement publication, in the *Longboat Observer*, for the Week of February 18, 2004.
