It was moved by Kerwin, seconded by Shapiro, for the Committee Summary Report to the Town Commission include support for the proposed Community Center, utilize the existing Bayfront Park Recreation Center property to construct a future recreation center, and continue with the general concept and site plan as developed by Wannemacher Russell Architects, inc. Motion carried unanimously.
