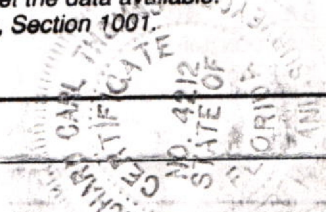
SECTION E CERTIFICATION

Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.

COMMENTS: The elevations shown hereon were determined by differential leveling to and from the Bishop & Associates Benchmark at the northwest corner of Lot 16, Block C, published elevation 5.94'. A total of 3412 square feet is enclosed by garage and crawl space with 26.73 square feet of holes provided for said enclosed area below the base flood elevation.
