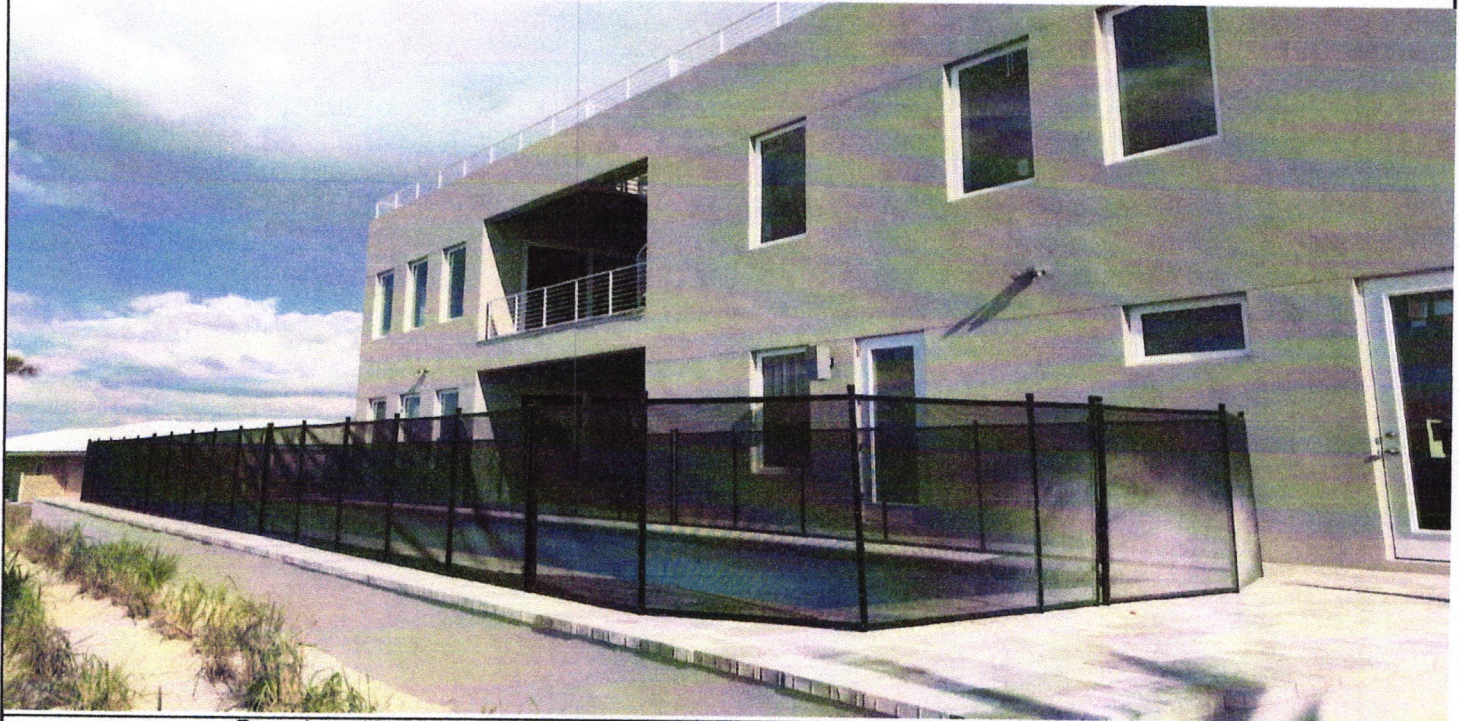
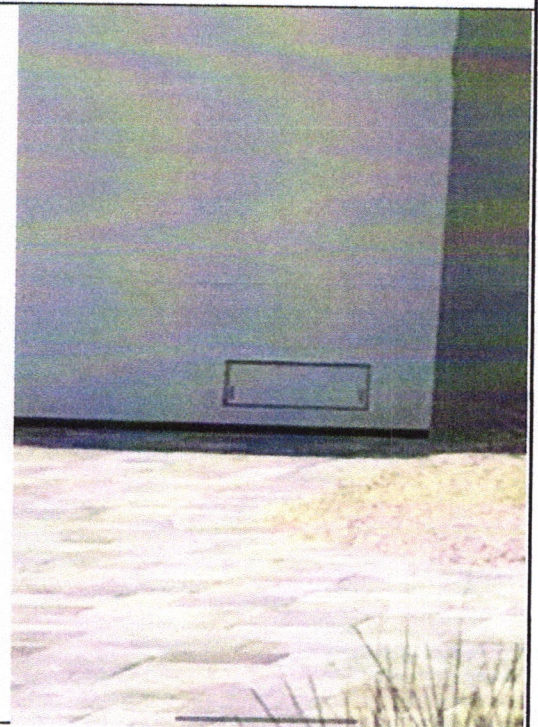


Photo One Caption Rear view with pool, cage and decking
