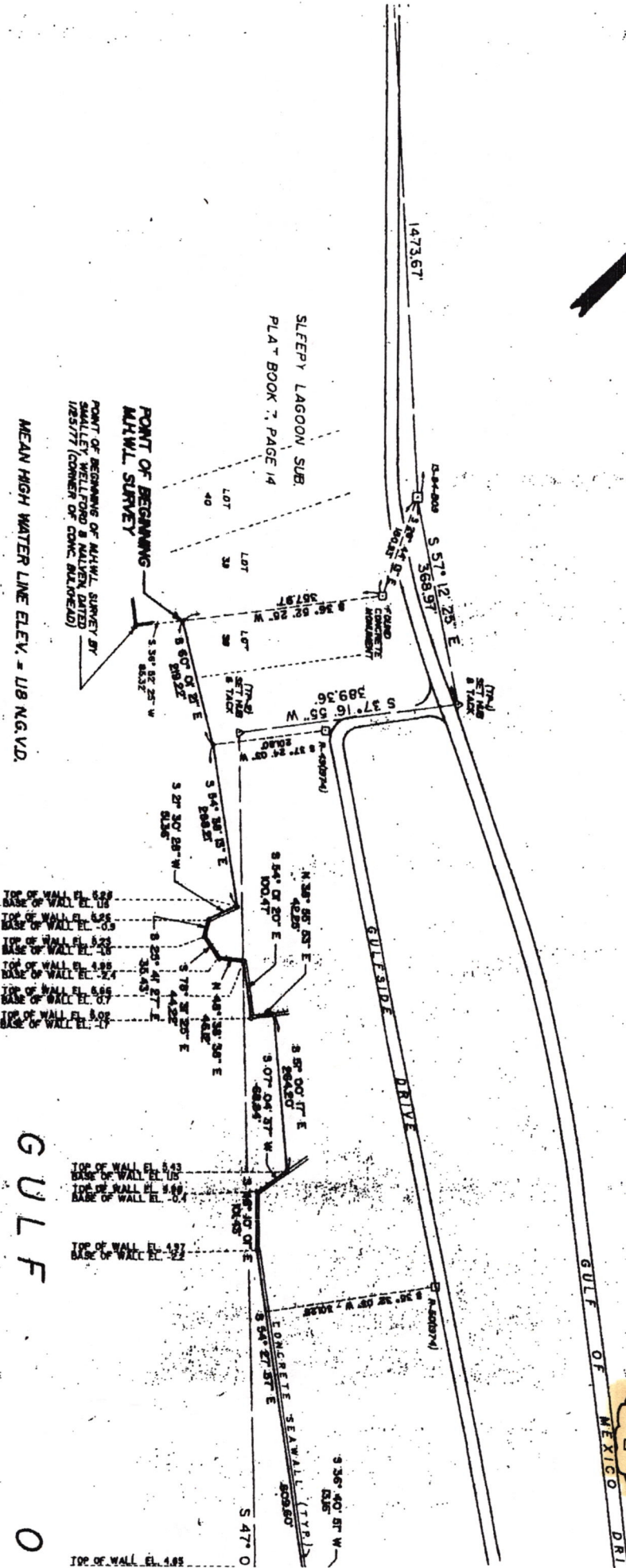


LOCATION MAP
