Hi Patti,

Attached is the EC 310 permit list spreadsheet to complete – please use this instead of the one provided by Bradley with ISO. I have added a "Variance Issued?" column to the spreadsheet, which corresponds to Item G11 on the new EC. This column should be answered for all ECs. This along with the "New Bldg or SI/SD?" column will allow us to address the new CRS requirements for G8 and G11, regardless of what is marked on the ECs.

We'll use the same process as last year, which I have outlined below.

Note that the timeframe we'll use is **April 1, 2023 – March 31, 2024**, based on the sign/seal date of the EC. That will give us a month buffer between our period of review and the May 1<sup>st</sup> deadline for submittal. CRS is good with this adjusted time frame. Please send me the ECs by **Monday, April 1<sup>st</sup>**, uploaded to Dropbox: EC 2024 - Longboat Key. Let me know if you cannot access that folder or need another option. My goal is to have the review completed by Friday, April 19<sup>th</sup>, so there is time before the May 1<sup>st</sup> deadline to ISO.

The ECs that should be added to the spreadsheet and provided are:

- Finished Construction ECs only
- New construction of a principle building in the SFHA (i.e., VE, AE, AO, AH, A)
- Substantial improvement of a principle building in the SFHA (i.e., VE, AE, AO, AH, A)
- DO NOT INCLUDE: accessory buildings or non-building construction (e.g., cell towers, fences)
- DO NOT INCLUDE: additions that are NOT SI
- DO NOT INCLUDE: under construction or pre-construction ECs
- DO NOT INCLUDE: X or X-500 buildings of any kind

For the EC PDF files, please provide them in <u>COLOR</u> with all attachments, and with the naming convention: 'Street\_Name' 'Street\_Type' 'Street\_Direction' 'Street\_Number' 'Bldg or unit Number'. For example:

AC Skinner Pkwy 7738 Bldg 8000.pdf Chaffee Rd S 500 Lot 191.pdf Old Kings Rd 5349-4.pdf Validus Dr 10660.pdf

You can add the permit number to the file name if that's helpful for you, but please place it at the end of the file name. I am reviewing ECs for 8 communities, and with so many to review, I'll need them in alphabetical order by street to efficiently review.

### Dear CRS Coordinator,

Our records indicate that you have either recently finalized, are scheduled for, or are currently in the middle of a full Community Rating System (CRS) cycle verification this year or last year. This means you are required to complete your Annual CC submission instead of a recertification. I am currently your CRS Resource Specialist and will be working with you through this process. Your Annual CC submission this year is due May 1, 2023.

### What Is Needed?

- You are required to submit your Permit List (see attached template)
- <u>Finished construction</u> certificates (CCs) (Elevation Certificates or Floodproofing Certificates, V Zone Certificates, and Engineered Opening Certificates)
- Remember, only new construction or Substantial Improvement/Substantial Damage CCs in the SFHA are required.
- \*Your Specialist may continue to email you separately about any other documentation still be needed if your Cycle visit is still open.
